The CHRO dashboard


This dashboard provides a "total HR" view along with detail and overview screens.

Discovery boards

- Ability to build reports and visualizations intuitively by dragging and dropping fields onto the board.
- Option to share multiple pieces of analysis as boards can have an unlimited number of sheets, each supporting up to 10 visualizations.
- Ability to bring boards into homepages as worklets.

Prism analytics

- Facilitates an accurate realtime and holistic view by bringing all the data together to support integration and data management capabilities.
- Provides functionality to create data sets and secure these data sets to reports/dashboards within Workday.

Adaptive insights

- Uses augmented analytics technology to surface prioritized workforce insights in the form of key metrics and business questions, along with their underlying drivers.
- Insights include opportunities and risks identification, pattern detection, and workforce development tracking.

KPMG grant funding executive dashboard

KPMG has also developed a Grant Funding executive dashboard that makes it easier to track and manage research and clinical care programs that rely solely on or in part on grant funding. The data that feeds this dashboard is sourced from the National Institute of Health and allows organizations to dive deeper into their historical trends in grant funding and benchmark themselves against other industry leaders. A deeper look into this data will allow users to identify top administering organizations, researchers, award categories to identify opportunities.
